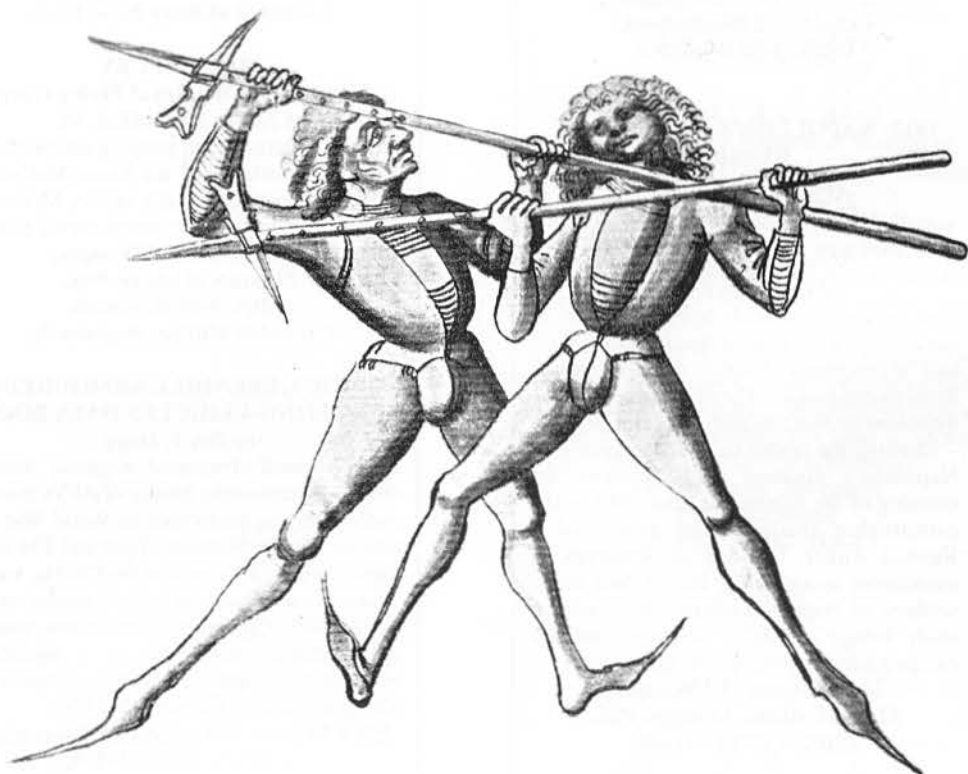

## FOREWORD

### A MODERN RENAISSANCE IN MEDIEVAL MARTIAL ARTS

Today the term 'martial arts' is usually assumed to be synonymous with 'Asian fighting art'. This is no surprise since popular media are notorious for misrepresenting medieval fighting. The medieval warrior's craft is often reduced to the myth that combatants merely crudely bludgeoned one another or hacked and slashed savagely. Yet well established, highly sophisticated European fighting systems existed. European 'masters of defence' produced hundreds of detailed, well-illustrated technical manuals on their fighting methods, and the people of the Germanic states were especially prolific. Their manuals present to us a portrait of highly developed and innovative European martial arts based on sophisticated, systematic and effective skills. Among the best known of these works is that of Hans Talhoffer. His influential treatise, first produced in 1443, was reproduced many times throughout the century.

Here now is the first English-language edition of the definitive work of this *Fechtmeister* (literally, 'fight master'). Talhoffer, probably a follower of the Grand *Fechtmeister* Hans Liechtenauer, reveals an array of great-sword and two-handed sword techniques, sword and buckler moves, dagger fighting, seizures and disarms, grappling techniques, and the Austrian wrestling of Ott, a rare medieval Jewish master of whom little is known. The illustrated plates also show methods for judicial duels – official fights to end legal disputes – and fighting with pole-weapons. Like many other medieval fighting texts, Talhoffer's manual covers fighting in full armour and without armour.

His manual reveals a range of both rudimentary and advanced techniques and provides a firm foundation on which to begin exploration of Western martial culture and the skills of medieval masters of defence. His manual covers fighting with swords, shields, spears, staffs, pole-axes and daggers, as well as grappling, throws, takedowns, holds and ground-fighting skills. Like many other teachers of his day, Talhoffer recognized that armed and unarmed fighting were only facets of personal combat and he accordingly taught an integrated art. He was greatly concerned with



secrecy in both the teaching and learning of his skills, for if a fighter's style were known he could be vulnerable, and a master's teaching was his own to give out as he saw fit. Talhoffer's manual was not widely distributed until after his death, and even then it must have circulated very slowly among groups of practitioners.

Whether your interest is academic, historical, theatrical or martial, Talhoffer's work offers today's student of European martial culture a strong starting point. While not a complete guide book on fighting from the period, it will encourage the reader's own practice and understanding of the brutal effectiveness of European warriors as well as the artistry of their craft. Like many others, for years now I have been interpreting and practising Talhoffer's techniques. I have studied his instructions and followed his advice with real weapons and with safe sparring tools. It has been a long but fruitful process and while such investigation remains ongoing and new insights continually appear, there is no question of the martial value and legitimacy of his teachings.

It is exciting that we are currently seeing a 'renaissance' in the study of Western martial culture as research and study of historical European fighting arts now undergoes something of a revival. Increasingly, enthusiasts of historical fencing today are focusing on legitimate methods rather than mere competitive games and role-playing pursuits and a much greater appreciation for the sophistication and effectiveness of medieval and Renaissance fighting skills has emerged. A new generation of serious practitioners and researchers is approaching the subject not as escapist fantasy or entertainment, not just as theatrical display, but as the study of a true martial art.

Earnest practice of the methods of medieval and Renaissance weaponry is increasing in popularity today as students rediscover the many works of European masters of defence. A renewed interest in and appreciation of the formidability and complexity of both medieval and Renaissance arms and armour has evolved. Most satisfying is the tremendous increase in the availability of translations of the old fighting manuals, but even so we have only begun to scratch the surface in the serious study of medieval fighting arts. Talhoffer's *Fechtbuch* ('fight book') represents the tip of a very large iceberg.

## INTRODUCTION

This is the very first English translation of Master Hans Talhoffer's *Fechtbuch*, or 'Fight Book', from the year 1467, one of the most influential and lavishly drawn fencing manuals of the fifteenth century. Talhoffer (c1420–c1490) was master of arms to the Swabian knight Leutold von Königsegg, a feudatory of Count Eberhardt the Bearded of Württemberg.<sup>1</sup> At least six illustrated manuals were produced under Talhoffer's name, covering an astonishing variety of armed and unarmed combat techniques. The most commonly known manuscripts were drawn in 1443, 1459 and 1467. Fencing scholar Gustav Hergsell discovered this last manual at the end of the nineteenth century in the library of Ernst II, Duke of Saxe-Coburg-Gotha, and translated the original Swabian text into German, publishing his version in Prague in 1887.

Hergsell describes Talhoffer's manuscript in his introduction:

The original drawings were made with pen and ink on parchment sheets, and boldly coloured. The cross is drawn in red upon the shields, caps, chests and backs of the shield-fighters. In some of the drawings, blood spurts from wounds, and the shields are coloured yellow. The drawings appear on both sides of each leaf.

The captions ... are inscribed in a bold hand. They alone set out the particular fights, as this codex contains neither a title nor any other text.

Next to the final illustration, showing a fight on horseback with crossbow and spear (jousting lance), Talhoffer himself is depicted, sword in hand, with the inscription, 'This book was written by Hans Talhoffer, who posed for this portrait.'<sup>2</sup>

As Hergsell notes, this book contains no explanatory text beyond the captions to the illustrations, and these are often oblique and open to multiple interpretations. The illustrations themselves are not always arranged to form coherent sequences. Personal combat training was a highly competitive field in medieval Europe, and fencing masters zealously guarded the secrets of their craft. Talhoffer's manuscript is often intentionally arcane. Yet it was not written as a fencing treatise, nor, strictly speaking, a 'how to' book. Rather, Talhoffer meant it as a declaration of his ability as a master of arms, and as a professional field manual for the

practical application of killing techniques with the prescribed weapons. A certain amount of martial knowledge and skill is assumed of the reader, and many things are left unsaid. However, with a little effort, the mists obscuring the master's teachings may be blown clear and his true meaning revealed. The captions to the plates are freely, rather than literally, translated from the original Swabian (which can be found in the Appendix to this book), and expanded in some cases. Additional explanatory information can be found in the translator's notes. While I have endeavoured in my translation to remain true to the original text, I have taken care to make the captions understandable to the modern reader, without resorting to too much modern or medieval fencing jargon.

Two plates in Talhoffer's *Fechtbuch* are not included: 127 (an almost blank leaf, with barely distinguishable outlines showing a shield fight in all openings), and 222 (a blank leaf).

The individual sections in Talhoffer's book may be divided into two sorts: those dealing with the 'judicial duel' and those concerned with personal combat. The judicial duel was an officially sanctioned fight to resolve a legal dispute, and was common in Western Europe from the tenth through the fifteenth century.<sup>3</sup> Talhoffer illustrates noblemen fighting a trial by combat in full armour with the sword and the spear. For commoners, the judicial duel involved unique and occasionally bizarre weapon combinations and ritual costumes: the combatants were stitched into cowled leather suits, greased with pig fat, and armed with a selection of wooden maces, swords, and spiked and hooked shields. These trials were rarely 'first blood' affairs, but duels to the death.

One of the most curious episodes Talhoffer illustrates is a judicial duel between a man and a woman.

The man stands in a circular pit up to his waist, armed with a club in his right hand, with which he assays to strike at the woman. He is severely prohibited, upon pain of forfeit, from stepping out of the pit. He may, however, steady himself with a hand on the edge of the pit or on the ground.

The woman has a veil in her hand, in which a stone of several pounds is knotted. With them she attempts to strike at the man. As soon as the woman is able, she moves behind the man's back, endeavouring to drag his head to the edge of the pit and to strangle him. The woman strikes a blow with her veil, which the man parries with his club. But the veil wraps itself around the club and the woman seizes upon this advantage to wrench the club from the man's hand, disarming him, ending the combat and levying guilt unto the man.

However, if the man parries the blow with his free left arm, he is presented with the opportunity to grab the woman about the waist, and to drag her into the pit, ending the fight unfavourably for her.<sup>4</sup>

In this particular duel, if the man is dragged from the pit or the woman into it, the 'forfeit' is to be taken off and immediately executed.

The majority of the manuscript deals with personal combat. Talhoffer includes lengthy illustrated passages on wrestling, unarmoured fighting with the long sword, messer (the 'long knife', a civilian weapon often pictured in Breugel's lively peasant scenes and similar to the hunting hanger, falchion, or ancient saxe), pole-axe, dagger, sword and buckler, and a series of mounted techniques. Talhoffer's manual amply proves that a unique, indigenous and systematic method of fencing and training with a wide array of weapons had developed in Germany during the Middle Ages, reaching its height in the fifteenth century. This is the German *Kunst des Fechten*, the 'art of fighting'.

## THE GERMAN ART OF FIGHTING

*Princes and Lords learn to survive with this art, in earnest and in play. But if you are fearful, then you should not learn to fence, because a despondent heart will always be defeated, regardless of all skill.*<sup>5</sup>

Germany in the Middle Ages was a conglomeration of small principalities ruled by dynastic houses, bishoprics, municipal leagues, towns, and villages all struggling against each other for advantage and privilege. Warfare was a part of everyday life. Not only were there the full-scale wars of conquest and plunder sanctioned by the German Emperor, but petty 'private' wars also flourished at this time, fought between princeling and town, town and village, bishop and town, and every combination therein. Knights banded together into societies of self-interest and hired out their services. Renegade noblemen preyed upon travellers on the lonely trails through the dense German forests. Tradesmen and artisans in the larger towns formed fencing societies, which undertook the training and licensing of teachers. The two most famous of these societies, the *Marxbrüder* (The Brotherhood of St. Mark, of which the artist Albrecht Dürer was a member) and the *Federfechter*, provided champions to the court of the Holy Roman Emperor.<sup>6</sup> In Talhoffer's native Swabia, Count Eberhardt of Württemberg maintained one of the best military forces in Germany, consisting of a small knightly cavalry and an infantry levy of commoners trained on regular exercises and frequently lent to neighbouring powers.<sup>7</sup> The inherently violent nature of medieval society meant that no distinction was made between the civilian and military application of the German martial arts.

Medieval German swordsmanship pedagogy can be traced back directly to Johannes Liechtenauer, who lived during the fourteenth century.<sup>8</sup>



Liechtenauer travelled Europe to learn the mysteries of armed combat and devised a simple system of precepts for the long sword, which could be applied to every weapon. He put his teachings into verse and began the tradition of safeguarding the secrets of his art by obscuring his true meaning. After his death, his pupils began writing down his methods to prevent them from being corrupted, laying the groundwork for a strong and simple tradition of armed combat that would endure for almost three hundred years, until it was supplanted in the seventeenth century by the Italian 'thrust fencing' of the rapier that swept over Europe.

The German martial arts were divided into armoured, unarmoured and mounted fighting, all of which are represented by Talhoffer. His manuscript begins with a series of drawings on the use of the long sword before moving on to other weapons. Medieval swordplay was not the hacking, blade on blade, ring of steel affair represented in films and on the stage. Medieval swords were amazingly light and well balanced, weighing between only two to four pounds. Combatants in the Middle Ages used footwork, avoidance, and the ability to judge and manipulate timing and distance to exploit and enhance the sword's inherent cutting and thrusting capabilities. These skills were supplemented with techniques for grappling, wrestling, kicking and throwing the opponent, as well as disarming him by seizing his weapon. The primary tactical principle of the German art of fighting is to attack and defend in single time. In other words, every attack contains a defence and every defence contains a counter-attack.

## AN OVERVIEW OF MEDIEVAL GERMAN SWORDFIGHTING

### Holding the Sword

The sword is held with the right hand close to the cross guard. The left hand rests below the right, and controls the levering actions of the sword. The left hand may also cup the fig-shaped pommel for more manoeuvrability and reach, and to increase the power of thrusts. The sword is held for the most part with the edges up and down, perpendicular to the ground.

### Stance

The swordsman faces his opponent squarely, with his hips and torso parallel to him, and his legs slightly bent. He may stand with either leg slightly forward.

### Footwork

The footwork is as simple and direct as walking. The fighter steps naturally

forward and back, from side to side and diagonally, and pivots on one leg or another to circle his opponent. Footwork is used to maintain distance, avoid blows, and close in for attacks. All cuts are accompanied by a step, either forward or back.

### Cuts

Cuts are divided into cuts from above and cuts from below (*oberhau* and *underhau*), as in plate 1. Cuts are made most often with the 'true' edge, the lower edge aligned with the knuckles, but may also be made with the 'false' edge, the upper edge aligned with the thumbs. There are three kinds of cuts: powerful cuts from the shoulders and body, medium cuts from the elbows, and harassing cuts made from the wrists and hands. Footwork is directly tied to cutting, which Talhoffer addresses in plate 9 with the caption, 'This is the strong way to fight going left to right.' This is a reference to the fact that the combatant must step into each cut, so that the weight of the body and torque of the hips may help deliver it successfully. With a cut from the left to the right, the swordsman must step forward with the left foot as the cut lands.<sup>9</sup>

### Thrusts

It is surprising how many thrusts Talhoffer shows, as the medieval sword is thought of as primarily a cutting weapon. However, it is evident from this manuscript that the German art of fighting placed a heavy emphasis on actions along the opposing blade resulting in thrusts. As with the cuts, thrusts come from above and below. Thrusts are most often aimed at the two lower 'openings' or targets in the soft parts below the ribcage, on the right and left side of the body (plates 6 and 14). They may also be aimed at the two upper openings, on the right and left of the body above the line of the ribcage. Other targets include the wrists, the feet, the thighs and the face.

### Guards

Talhoffer illustrates a number of guards, wards or stances, each with a characteristically colourful mnemonic name. Thus, we have the 'iron gate' (plate 16), the 'squinting' guard (plate 36), and the 'fire-poker' (plate 39). The guards are not static positions of defence. Rather, they are moments of transition from which cuts and thrusts begin or end. The guards are fluid, flowing from one to another, and should be thought of as positions from which to initiate attacks.

The four basic guards in the German art of fighting are the low or 'iron gate' guard; the middle guard or the 'plough', with the sword hilt held in front of the body at waist height with the point directed toward the enemy; the right and left hanging guards or 'oxen', with the sword hilt held at the side of the head and the blade lowered diagonally across the body and

directed toward the enemy (plate 13); and the high guard, with the sword held directly above the head, pointing back at a 45-degree angle and from which cuts may be made *von tach*, or 'from the roof'.

### Attack and Counter-Attack

As mentioned above, the primary tactical principle of the German art of fighting is that for every attack there is a counter-attack (*stuck und bruch*). Attacks are met with counter-cuts and thrusts that set aside the enemy's weapon to force a way through the enemy's guard. Counter-attacks may be combined with avoidance, grappling, wrestling and disarms to render the opponent defenceless.

### Avoidance

The first means of defence open to the swordsman is to avoid the attack: to be where the sword is not. This may be accomplished by stepping back out of distance. However, a cutting sword moves with the most force at the point of percussion, a few inches below the point, and with the least force near the hands. Therefore, a more effective technique for avoidance is to close the distance by stepping toward the opponent, moving straight in or diagonally to either side, and counter-attacking, grappling, or making a disarm.

### Setting Aside

Attacks may be countered by setting them aside with the blade, or *versetzen*. Similar to the modern fencing 'parry', setting aside is an action that deflects the oncoming steel by either cutting directly into it to strike the opponent, or by redirecting its force with the blade to gain an advantage over him. Talhoffer never shows anything resembling static, blade on blade blocks. His setting aside techniques are fluid and dynamic, and lead naturally into counter-attacks.

### Grappling

Nearly a third of Talhoffer's long sword plates include some form of grappling. When the distance between the combatants is closed suddenly, the sword becomes ineffective. Grappling is used to regain proper fighting distance, to throw the opponent off balance, and to disarm him.

### Binds and Weak vs Strong

Talhoffer illustrates many techniques that come from a bind or crossing of the swords with opposition (plates 29–32, among others). Once the swords are bound or crossed, a deadly game of leverage begins. The sword is naturally 'weak' near the point and 'strong' near the hands, so a swordsman may lever his opponent's blade by applying the strong part of his sword to the weak part of his enemy's sword. There are also weak and strong forces

of opposition. In a bind, the swordsman may apply a weak force to his opponent's strong force and allow the enemy steel to pass through the bind, freeing his own blade for attack. In addition, strong pressure may be applied in order to break through the opponent's guard or to use the enemy's sword as a guide to direct thrusts at the opponent's body.

### Half-Sword

The half-sword techniques were originally devised for fighting armoured opponents (plate 26). The sword is gripped on the blade with the left hand and used like a short spear or bayonet to slice or stab into the armpits, groin, face, throat and joints. The superior leverage of the half-sword may also be used to perform actions on the opponent's blade, setting it aside or trapping it.

In emergencies, the sword may be reversed to thrust the pommel at the opponent's face (plate 38), or held by the blade with both hands to use the cross hilt to hook, trip or disarm. The reversed sword may also be wielded like a large hammer, resulting in terrifying blows called the 'murder stroke' or *mortschlag*, and 'thunderclap stroke' or *donnerschlag* (plates 33 and 37).

The techniques described above for the long sword may be applied to any hand-held weapon. You will note half-sword actions used with the pole-axe, setting aside techniques with the duelling shields, grappling with the messer. Every weapon in Talhoffer's arsenal is wielded in the four basic guards and used to make cuts and thrusts from below and above.

The German art of fighting is simple, direct and effective. It has only one object: the swift demise of the enemy by any means.

## TALHOFFER'S ARSENAL

### Long Sword

(plates 1–67, 74–8)

The long sword, war sword, hand-and-a-half sword, or bastard sword is the chief weapon of Talhoffer's arsenal, and the fundamental techniques for its use may be applied to every other weapon in his book. The long sword is between four and four-and-a-half feet in length with a sharply tapered double-edged blade of diamond profile, a simple cross hilt, a fig-shaped pommel, and a handle long enough to be gripped with one or both hands. This weapon is surprisingly light, capable of making blindingly fast attacks, and is suitable for both cuts and thrusts. As the



plates illustrate, the entire sword is used, either by gripping the blade with the off-hand for strong half-sword attacks, or reversing it to strike with the pommel or to employ the hilt as a hammer to batter through the opponent's defences.

### Armoured Fight with Spear and Long Sword

(plates 68–73)

The armoured fight with spear and sword is a judicial combat between noblemen in full plate armour. They begin the ritual by sitting on a platform in the lists (the barriers surrounding the duelling ground) and displaying their weapons, with their attendants beside them and their coffins before them. The spear is used as the primary weapon, with the sword held in reserve for the *coup de grâce*.

### Pole-Axe

(plates 79–103)

The pole-axe is most commonly used in armoured fighting, and is specifically designed as an 'armour-breaker'. Talhoffer, however, shows it in unarmoured fight. Talhoffer's weapon is a 'Lucerne Hammer': a long staff weapon with a notched hammer head surmounted and surrounded by sharp spikes. The shaft is used to trip the opponent by sweeping his legs, or to thrust him in the head or chest. The spikes at the side and back are used to hook and drag the opponent to the ground, and the long, blade-like spike on top is used to make killing thrusts. Although the pole-axe is primarily a knightly weapon, the techniques for its use are equally applicable to the axe-bladed halberd, the weapon of choice for the select combatants held in reserve for counter-attack in the centre of the formidable pike formations of the Swiss Confederates and German *Landsknechte*.<sup>10</sup>

### Duelling Shield

(plates 104–64)

The duelling shield is used in judicial combat. It is a slightly concave oblong, approximately six-and-a-half feet tall, with a rectangular coffered boss along the longitudinal axis allowing room for the hand to grip a central pole, which is sharply spiked at both ends. The shield is made of wood, possibly covered with cloth or leather, and bears the image of the cross. It is used both defensively and offensively to deflect blows and hammer into the opponent's shield to create openings, as well as to stab with the spikes. The combatants are barefoot and sewn into tight-fitting cowed leather suits with a red cross on their chests and backs and the back of their cowls. When fighting according to the Frankish law, the combatants use a large wooden mace with their shields. When fighting according to the Swabian law, they employ the long sword.

### Throated Hooking Shield

(plates 165–9)

The throated hooking shield is perhaps the most unusual weapon in Talhoffer's arsenal. It is a cello-shaped affair with four protruding hooks at the top and bottom for catching, pulling and stabbing the adversary. Like the simple duelling shield, it has a sharply-spiked central pole which may be used to impale the opponent.

### Dagger

(plates 170–89)

The dagger is the ultimate weapon of last resort. Talhoffer shows the rondel variety with an extremely long, triangular blade and a grip with two flanges at top and bottom to protect the hand. The dagger is the simplest and most commonly carried weapon of medieval Germany. Techniques are illustrated for using the dagger to shield against stabs, gripping the blade with the off-hand to create locks on the opponent's dagger, blocking with both the dagger arm and the off-hand, and grappling.

### Wrestling

(plates 190–221)

Nearly a third of the armed combat plates show some kind of wrestling or grappling, and Talhoffer devotes thirty-two plates to wrestling alone. Wrestling is essential to the German art of fighting, since the fight must become hand-to-hand once distance is closed within the effective range of the weapons, or if either of the combatants should be disarmed. Talhoffer borrows his wrestling techniques from Ott, an earlier wrestling master to the Habsburg Dukes of Austria.<sup>11</sup>

### Messer

(plates 223–30)

The messer, or 'long knife', has a short, single-edged blade with a simple cross hilt. The blade is slightly curved and the last few inches of the clipped back or false edge are sharp. It is carried in one hand, with the other hand held behind the back as in modern sabre fencing. The messer resembles the ancient saxe, falchion, the Italian storta, the Bohemian dusak (a wooden training weapon used in Germany into the seventeenth century), the Polish sabre, and the modern machete. Commoners in medieval Germany carried it as an everyday side-arm. The messer is capable of making shearing cuts fierce enough to remove a hand from the arm, as can be seen in plate 228. Albrecht Dürer devotes a large section of his *Fechtbuch* to the messer (see bibliography).

### Sword and Buckler

(plates 231–41)

We get the word 'swashbuckler' from the British proclivity for the sword and buckler. This weapon combination was in use across Europe since the twelfth century. The oldest fencing manual in existence, the anonymous thirteenth-century German manuscript I.33 in the collection of the British Museum, is entirely devoted to the sword and buckler. The buckler is a small, round shield with a central boss (a bowl-shaped protrusion allowing room for the hand) and handle. It is used with a single-handed sword with a simple cross hilt and a large circular pommel. Talhoffer's buckler is rather ornate, with two hook-like protrusions at the top and bottom for catching and deflecting the oncoming blade. At the end of this section, Talhoffer shows techniques for one man fighting against two.

### Combat between a Man and a Woman

(plates 242–50)

The fight between a man and a woman, as described above (pp.10–11), is another judicial duel in which the man is placed up to his waist in a pit and armed with a large wooden mace. The woman is free to move around him on the ground, and is armed with a three- or four-pound stone knotted into a long veil.

### Mounted Combat

(plates 251–70)

The final series of plates shows methods of mounted combat with the long sword, long sword against the lance, lance against crossbow, and mounted hand-to-hand fighting.

## FOR THE MODERN READER

The Western martial heritage, encompassing a broad array of weapons, each with its own sophisticated methodology, is being rediscovered by a new generation of fencers. Scholars, students and practitioners all over the world are devoting time and study to reviving European armed combat as a living martial art. Forgotten and neglected ancient fencing manuals are being dusted off and used by modern swordsmen and women to apply historically accurate techniques to train and fence with edged and pole weapons long dismissed from the arsenal of the conventional fencer.

Talhoffer's book provides us with an unparalleled visual reference. Each drawing is a carefully composed snapshot isolated in time, revealing the elegant intricacies of the German art of fighting. The illustrations may

be thought of as flash-cards to prompt the memory, and may be rearranged to discover connections and sequences of action. Used in conjunction with other manuals of this period which are richer in text, such as those by Sigmund Ringeck (c1440), *Fiore dei Liberi* (c1410) and Joachim Meyer (1570), we are able to reconstruct these personal combat techniques as they were actually practised in the Middle Ages. This book was meant to be used. And it can be used by the modern martial artist, but only by working through it carefully, with full respect for the martial heritage it represents and the dangerous and lethal nature of the skills it would impart.

For the stage and film fight combatant or choreographer, this *Fechtbuch* offers an exciting vocabulary of moves, actions and weapons, many of which have never before been seen by an audience. Because Talhoffer's techniques are authentic, they are bio-mechanically sound and easy to learn and practise safely. They can be exploited to enliven the tired 'parry and riposte', edge-gouging swordplay so common in the theatre and on the screen today.

Beyond this manuscript's appeal for the martial artist or stage swordsman, it possesses great aesthetic beauty and historical interest. We do not know for certain who drew the figures in Talhoffer's manuals. Whether it was Talhoffer himself or some anonymous Swabian scribe, the artist took painstaking care to give each of the figures life and expression. We are treated to images of everyday dress, with doublet, codpiece, hose, a variety of headgear and the extravagantly pointed shoes of the late Middle Ages; full suits of armour; ritual battle dress; and equestrian equipage. This book is a time machine, providing us with a glimpse of real people really fighting with all the skill, sophistication and ruthlessness of the *Kunst des Fechten*.

To paraphrase Gustav Hergsell, if I succeed in bringing the art lover, historian, fencer and stage combatant closer together through this priceless artifact of the German Middle Ages, I will have achieved my goal.

## NOTES TO PLATE CAPTIONS

1. The long sword, bastard sword, or hand-and-a-half sword is the quintessential medieval German weapon. This weapon is generally four to five feet long, double-edged and sharply tapered. Talhoffer's long sword has a simple cross guard. The grip is long enough to accommodate both hands, though it may be managed with only one. Contrary to popular notions of this weapon, the medieval long sword is surprisingly light, weighing an average of only three pounds, and capable of blindingly fast attacks. The techniques for its use may be applied to every other edged or pole weapon in the medieval warrior's arsenal.
2. The plunging cut is made from above with the false or back edge of the sword.
3. In medieval swordsmanship every attack is met with an immediate counter-attack that is both offensive and defensive at the same time.
4. The shifting cut is one in which the attack changes direction as it is being made, passing around the opposing blade.
5. The thrust of wrath is a powerful downward diagonal thrust from the right (see note 45).
6. The crosswise thrust is made by pivoting the sword so that the right wrist crosses above the left wrist. In general, actions that result in the crossing of the arms or wrists are weaker than uncrossed actions. See also plate 31.
7. This is an example of the medieval custom of using mnemonic devices for naming actions of the sword. The cut from the roof moves vertically downward.
8. The body is divided into four openings or targets: upper and lower at the horizontal line of the ribcage, right and left at the vertical axis of the body.
9. A cut must arrive with a step of the foot from the same side as the cut originates. This allows the weight of the body and the torque of the hips to set the cut. In plate 9, the swordsman on the right is cutting from left to right, timing the cut to land with a step forward with his left foot. This has the additional defensive advantage of interposing his blade between himself and the enemy's steel. I am indebted to Norbert Krines of Bamberg, Germany, for his insight into this caption. See also Introduction note 9.

10. The bind is a crossing of weapons with opposition or pressure.
11. The iron gate (*eisen port*, *porto di ferro*) is a basic defensive guard with the long sword, protecting the legs and lower body.
12. The crooked cut is a downward cut made with the false or back edge of the blade, causing the swordsman's wrists to twist.
13. This plate illustrates the brutal reality of long sword fighting: two adversaries locked closely together in a life-and-death embrace from which only one may emerge alive.
14. The hanging guard (*ochs*, or 'ox') is made with the hands held high and close to the side of the head and the blade covering the body diagonally downward and directed toward the opponent. See plates 6, 13, 14, and 259 for other examples.
15. The half-sword was originally used against an armoured opponent. The sword is gripped on the blade with the left hand and wielded like a short spear. This technique is effective for close work, punching through chinks in armour (*ie* at the face, groin, armpits, joints etc) and attacks on the opponent's sword. See also note 21.
16. The coat of arms at the side of this plate is Swabian, bearing the date 1467. 'The arms are quartered: the first and fourth fields are gold with three black antlers upon each, representing the County of Württemberg; the second and third fields are red with two golden barbs upon each, representing the County of Mumpelgard. The crest surmounting the arms consists of a red closed helm and a gold-streaked trumpet to which is appended a black cord interwoven with gold. From out of the mouthpiece of the horn are three ostrich feathers: blue, white and red. The helmet drape is red and gold.' – Gustav Hergsell, *Talhoffers Fechtbuch aus dem Jahre 1467*.
17. The murder-stroke is a forceful blow struck by reversing the sword and gripping it by the blade with both hands in order to use the hilt as a hammer to pound through the opposing guard. Similar to the thunderclap stroke.
18. The squinting guard is one in which the sword is held close to the head with the blade parallel to the ground and pointing at the opponent, causing the swordsman to 'squint' down the length of his blade.
19. Another guard with a mnemonic name. In the *brentschirn* or the bind with the shortened sword, the blade is gripped by the left hand and carried with the point angled upward.
20. False in this case refers to a feint or fake attack designed to provoke a response from the opponent that can be exploited.

21. The translator has witnessed a demonstration of a sharp blade being held with a bare hand. As long as the blade is gripped firmly and not allowed to draw through the hand, the sword may be held securely in this manner, withstanding efforts to pull it away.
22. In this action the sword is shifted to the left hand so that the opponent's blade may be seized with the right hand.
23. *Versetzen*, to set aside, is another basic technique of medieval swordplay. Rather than meeting the oncoming blow with a solid block, it is set aside, displaced, or parried (to use the modern term) with an action that is both defensive and offensive at the same time.
24. This is a judicial combat or 'trial by battle' between noblemen in full armour using swords and spears. The 'lists' are the barriers within which the combat occurs.
25. The ceremonial display of the coffins underscores the lethal nature of trial by combat.
26. This is the fundamental principle of German swordplay: every attack is met with an immediate counter-attack which also serves as a defence.
27. The pole-axe takes many forms, but usually consists of an axe blade or hammer head and several sharp spikes affixed to a long pole partially sheathed in iron. Talhoffer's weapon is a 'Lucerne hammer', having a v-shaped notch in the forward hammer-like blade.
28. One interpretation of this manoeuvre is that the combatant on the left binds his opponent with the shaft of his weapon, disengages and swings the blade of his pole-axe into his adversary's head.
29. This is another form of ritual or judicial combat. Following the law of the Franks, the combatants are barefoot and stitched into tight-fitting cowled leather suits, upon the front and back of which appears the cross. They are armed with a large wooden club or mace and a special duelling shield. The shield is an oblong approximately six-and-a-half feet tall, slightly concave (see plate 149), with a rectangular coffered boss along the longitudinal axis allowing room for the hand to grip a central pole which is sharply spiked at both ends. The shield is made of wood, possibly covered with cloth or leather, and also bears the image of the cross.
30. A similar combat to the one before, except that the mace has been replaced with the long sword, according to the Swabian law. There is no Plate 127.
31. Possibly Schwabische Hall, a Swabian town which is the site of the largest fortified medieval church in Germany.

32. Note that the combatant on the left has his index finger hooked over the cross guard of his sword for better control.
33. A crosswise cut is a diagonal downward cut that moves across the body from right to left, forcing the swordsman's arms to cross.
34. This section illustrates techniques for fighting with the shield alone.
35. The combatant on the left is using a throat hooking shield (see note 38).
36. The combatants hold their shields with their arms reversed from the normal stance, allowing them to spin their shields.
37. The concept of weak versus strong (*schwache und starke*) is another basic principle of the German art of fighting. A sword is strong toward the hilt and weak toward the point. A shield or pole-arm is strong between the hands and weak outside the hands. Strong and weak also may refer to the pressure exerted by the weapons in a bind. A combatant may use the strong force of his weapon to create an opening against the weak force of his opponent's weapon. A combatant may also exploit the strong force of his opponent's weapon against the weak force of his own weapon to disengage suddenly and gain an advantage over his adversary. It is a deadly game of leverage, timing and judgement.
38. Perhaps the most bizarre weapon in Talhoffer's arsenal, the throat hooking shield is a cello-shaped affair with four protruding hooks for catching, pulling and stabbing one's opponent. Like the duelling shield, it has a long sharply spiked pole for a hand-hold and a rectangular coffered boss. The translator has seen these shields demonstrated and can assure the reader that they are formidably effective.
39. Talhoffer shows a 'rondel' dagger, with two flanges at either end of the grip and an extremely long triangular blade which may be held with the off-hand for blocks and locks.
40. The shield is a block made by holding the dagger with one hand on the grip and one hand on the blade, as with the half-sword. See also note 15.
41. The scissors-hold is a dagger lock in which the attacker's dagger hand is captured by the defender blocking the stab with his dagger arm, hooking his own dagger around the back of the attacker's wrist or forearm and closing the lock by grasping his own dagger blade with his unarmed hand.
42. More than a third of all the plates illustrating armed combat include some kind of grappling, demonstrating how important wrestling is to the German art of fighting. Talhoffer borrows his wrestling techniques from Ott, an earlier wrestling master to the Habsburg Dukes of Austria.

43. The German messer or 'long knife' is a single-edged, single-handed sword with a simple cross guard. The blade is slightly curved and the last few inches of the clipped back or false edge are sharp. It resembles the ancient saxe, falchion, Italian storta, dusak (a wooden training weapon of Bohemian origin), or Polish sabre, and was carried as an everyday side-arm by commoners in medieval Germany. The artist Albrecht Dürer devotes a large section of his *Fechtbuch* to the messer (see bibliography). There is no Plate 222.
44. In this manoeuvre, the swordsman cuts into his opponent's attack from below with his palm up, and then quickly snaps his messer around to the other side as the initial attack passes harmlessly by. The defender is now behind his adversary and has him at his mercy.
45. The cut of wrath is a powerful downward diagonal cut from the right. In preparation for the cut, the sword point is dropped behind the back.
46. This section illustrates the use of the single-handed sword and the buckler, a small shield with a round central boss for the hand. True to form, Talhoffer's bucklers have protruding hooks at top and bottom, which may be used to catch and deflect the opponent's blade.
47. There are two things of note in the illustration of the swordsman on the left. One is that the buckler must be carried well forward from the body to encounter a thrust. The other is that the position of the sword is that from which the cut of wrath is delivered.
48. Truly a bizarre judicial duel. Both opponents are in the tight-fitting leather garments of the trial by combat. The odds are evened by placing the man in a pit up to his waist and arming him with the wooden mace we saw in use with the duelling shields. The woman is armed with a 'rock in a sock', a three-pound stone knotted in her veil, and may move freely about the man on the ground above him. If she succeeds in pulling him out of the pit, his life is forfeit. Likewise, if he manages to pull her down into the pit, she faces instant execution.
49. What follows is a series of techniques for combat on horseback with a variety of weapons and hand-to-hand.
50. See note 14.
